Boarding and Day Girl attendance at Solway College is highly affordable and compares very favourably with similar schools. We are a 'State integrated School' with a commitment to maintaining affordability for our community. We offer very attractive terms which allow families to spread payments throughout the year without incurring additional charges.

## 2024 Other Payments

Fees and donations as listed above do not include expenses incurred specifically on behalf of students, such as uniform, stationery, lunches (day students only), 'personal' photocopying or any other consumables required during the course of the school year. Consumables charged by the school will be invoiced monthly to your account.

Lunches for Day Students are charged out at \$502.50 per term
